**SCREENING LICENSE**

License fee for screening the FILM is based on organizational status and audience size. (1-50) Veteran and nonprofit organizations \$250.00 / all other \$500; (50-100) Veteran/nonprofit \$500 / all other \$750; (100-500) Veteran/nonprofit \$1000 / all other \$1500. To upgrade this license to cover a larger audience or screen it more than once, submit request to [info@theunprescribed.org](mailto:info@theunprescribed.org).

In consideration of payment of the license fee provided for above, the LICENSOR will provide the LICENSEE with one (1) Digital Copy of the FILM to be used for the screening, electronic publicity materials (if any) and this license to screen the film once in front of 1 - 50 people. The LICENSOR agrees that the LICENSEE may charge admission to the screening and retain all monies received from ticket sales. The LICENSOR hereby grants to the LICENSEE, without warranty, a **limited, non-exclusive, non-transferable license to screen the FILM** on the SCREENING DATE only, subject to the terms and conditions specified herein, as follows:

- The LICENSEE hereby expressly agrees that the FILM shall be used only for the permitted purposes as set forth in this AGREEMENT and for no other purpose. \_\_\_\_\_ (*Initial Here*)
- The LICENSEE agrees that the FILM may be exhibited in more than one screening in a single location on the SCREENING DATE, but that **permission for additional exhibition locations and dates must be made to the LICENSOR by email or mail, at the addresses above, and may incur additional licensing fees.** \_\_\_\_\_ (*Initial Here*)
- The LICENSEE agrees that **it shall not permit the FILM to be duplicated, sold, loaned, transferred, televised or made available online or to any other party not contained herein** at any time or in any manner other than as provided for in this AGREEMENT. \_\_\_\_\_ (*Initial Here*)
- Panelist participation may be subject to speaker's fees not covered by this contract.

With respect to the License granted hereunder, **it is expressly understood and acknowledged by the LICENSEE that any rights, title, or interest that the LICENSOR maintains with respect to the FILM are expressly reserved by the LICENSOR.** This AGREEMENT constitutes the entire understanding of the parties with respect to the subject matter hereof, and any amendments, changes, or modifications shall have legal effect and be binding only if made in writing and signed by both parties.
